## Dominion Virginia Power Project Update

Are you wondering what happened with the Dominion Virginia Power Project on Huntley Meadows Park (HMP) property (see September's newsletter)? I'm pleased to report that we have a **WIN** for our **ENVIRONMENT**...a **WIN** for protection of our **NATURAL RESOURCES**...a **WIN** for **BIRDS**...a **WIN** for protection of **HISTORIC VIEWSHEDS**...and a **WIN** for protection of **HISTORIC, CULTURAL** and **ARCHAEOLOGICAL RESOURCES**. Friends of Huntley Meadows Park (FOHMP), Friends of Historic Huntley (FOHH), the County of Fairfax, and Dominion Virginia Power (Dominion) came to an agreement just moments before the State Corporation Commission hearing on the proposed power project was to begin on June 15, 2016. This agreement addressed our most significant concerns. Dominion agreed to lower the maximum height of the power poles from 125 feet as proposed, to 100 feet. This change virtually eliminates the adverse impact on the Historic Huntley viewshed. Lowering the poles also reduces, though does not entirely eliminate, the potential risk for bird collisions with the top grounding wire. We also agreed on certain requirements for a bird monitoring project in the project area. Dominion and FOHMP agreed that if these criteria are met within the agreed timeframe, Dominion will install, as a cost of the rebuild project, bird flight diverters along the entire rebuild section of the transmission line within HMP. If the agreement criteria are met, Dominion would also pay for a monitoring program to report on bird fatalities along the easement, and will publicly disclose data related to any such study.

We also asked, and Dominion agreed, that concrete washouts for the Rebuild Project utilizing the 100-Foot Structure option will utilize leak proof matting under the concrete washout pit to prevent all concrete residue from leaching into the soil or surface or subsurface water. This is required under EPA Stormwater Best Management Practice: Concrete Washout Document, EPA 833-F-11-006 (Feb. 2012), but it is important to remind everyone of the need to work with great care in this very sensitive conservation area. This re-statement of the EPA requirement accomplishes that. The concrete washout areas will be on Fairfax County Park Authority property (though not on HMP property).

Dominion agreed to prepare revised detailed alignment sheets showing the power pole base locations with respect to the location of wetlands, rare plants and the George Washington Boundary ditches for use by Dominion project staff and contractors. In addition, Dominion will identify on site "no-go zones" (areas to be avoided and marked as such to alert contractors by some type of on-the-ground marking). Dominion agreed to prepare (or have prepared) a detailed analysis of historic resources, which would include detailed mapping, document research, and historic plat analysis, in

## Monday Morning Bird Walk

As summer blends into autumn, the area bird populations change as well. September brought us some interesting adjustments to our home birds as well as some migratory species. Several juvenile Little Blue Herons spent a significant part of the summer in the central wetlands before leaving in mid-September. While annual visits of these birds is not unusual, having them stay for nearly two months at Huntley Meadows is. Moreover, this year's crop had several juveniles and at least one adult, whereas our previous visitors amounted to two or three juveniles at most. Cornell data shows regular sightings of Little Blue Herons in our area from August through September, but Huntley records show only a week or so for just a few birds.

On the September 20 Monday Morning Birdwalk, we were able to positively identify a Long-billed Dowitcher (LBD) mixed in with several other shorebird species. Old timers can remember an LBD in the very distant past, but we can't find a Huntley record. Any help would be appreciated. Also on the 20th, we sighted several species of shorebirds, among them a Stilted Sandpiper. We are still waiting for the on-rush of warblers, but as of this writing it hasn't happened. Stay tuned.

All are welcome to join the Monday Morning Birdwalk. We'd love to see you!

*The Monday Morning Bird Walk has been a weekly event at Huntley Meadows Park since 1985. It takes place every week, rain or shine (except during electrical storms, strong winds, or icy trails), at 7AM (8AM November-March), is free of charge, requires no reservation, and is open to all. Birders meet in the parking lot at 3701 Lockheed Blvd, Alexandria, VA. Questions should be directed to Park staff during normal business hours at (703)768-2525.*

## News from Park Manager Karen Sheffield

I hope you have been able to visit Huntley Meadows Park and witness the spectacular shorebird activity this season. If you missed it, the Long-billed Dowitcher seems to top the list as a new species record for the Park. (Yes, I'm expecting email comments on this!) Thank you to all the birders who document and report sightings. You play an important role in wetland management.

This season a birding day including five to nine species of observed shorebirds was not uncommon. Amongst the most often seen were Killdeer, Greater Yellow Legs, Lesser Yellowlegs, Solitary Sandpiper, Spotted Sandpiper, Semipalmated Sandpiper, Least Sandpiper, Pectoral Sandpiper, Wilson's Snipe, and very rare for the Park, Stilt Sandpiper and Long-billed Dowitcher.

Increased diversity and abundance of these birds is influenced by the relative attractiveness of the wetland to these species. Thoughtful wetland management and a little luck from Mother Nature with rainfall created these appealing conditions.

Although most of the shorebirds have now moved on, the diversity and abundance of native wetland plants this season will create a profusion of waterfowl food for this winter. With continued luck from Mother Nature and careful wetland management, it could turn out to be a fabulous winter season for these birds. Don't forget your binoculars! (If you do, we have a limited number of binoculars to borrow from the Norma Hoffman Visitor Center.)

particular of the George Washington boundary ditches in a specifically defined portion of the easement area. This detailed analysis will be completed before any rebuild work for the 100-foot structure option in the noted area within the easement is undertaken by Dominion. We thank Dominion for agreeing to these improvements to the Rebuild Project.

I would be remiss to not share with you that many hours, in fact many hundreds of hours, were spent researching current technical material, consulting with experts, preparing testimony, responding to questions, submitting testimony, copying documents, preparing more testimony, and all of this under very tight deadlines. My hope is that others who are faced with the daunting and intimidating task of challenging a large utility company that you will know that we were there once too. We leaned on each other and you can lean on us knowing that we support your efforts to protect the natural, cultural, historical and archaeological resources that might be gone forever without your efforts.

My deepest expression of thanks goes to our team members, Diane Donley (our attorney), Todi Carnes (President, FOHH), Carolyn Gamble (Board member, FOHH), and all members of the FOHMP and FOHH Boards of Directors. A special thanks to George Ledec who provided significant technical advice and guidance throughout this project. Diane Donley, our attorney, is a treasure beyond measure. Words cannot express how grateful we are for Diane's legal guidance and direction, and the commitment shown by her to this project.
